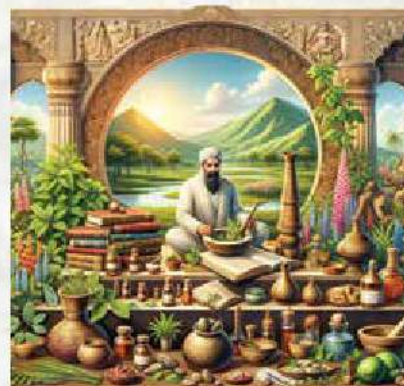


About Ayurveda

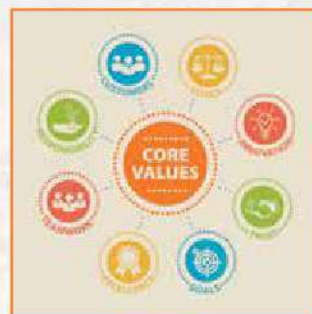
